* Candidates are considered having had satisfactory completion of Part III Fellowship (EXIT) Examination only if they have fulfilled all of the following requirements: completion of at least six years of supervised psychiatric training in an approved setting, completion of training in a minimum of three subspecialties as listed in the training handbook, satisfactory completion of training activities as approved by tutor, and satisfactory completion of Part III dissertation and oral examination.

Candidates have passed the Part III oral examination but have not completed the six years of psychiatric training yet. They have to submit a final edited typewritten version of their dissertation to the Board of Examiners, no sooner than two months prior to the end of their six years of psychiatric training, for consideration of an overall pass.
